Covers instruction center and reason for action required and no action required, disclosures tab and the view link for discloser to see a read only review of disclosure that was previously completed. Direction to Click the complete profile disclosure activity and provides discloser direction on how to update and add related context to help reviewer to make a determination.

Covers instruction center and reason for action required and no action required, disclosures tab for previous interests. Direction on clicking the Edit Disclosure Profile button, goes over how to complete the Disclosure Profile SmartForm and the instructions and policies area, the date that COI Training was completed area and direction to look out for the red asterisk on the required. It goes over a complete overview on how to make changes to the SmartForm. Direction to Click the complete profile disclosure activity and an alternative option of activities that can be taken if the profile is not complete and more information needs to be verified by discloser.

Direction to click the Request Pre-Approval activity and how to select the type of request and how to complete the Activity information SmartForm. Covers the Pre-submission state after submission of the pre-approval request, covers the activities that discloser can complete: submit, add comment, copy request (reason behind using this activity) or discard activity. Goes over the Pre-Approval requests tab and mentions email notifications that will be received when determination is made. Direction on how to enter the details that actually occurred as an interest in the disclosure profile after the pre-approval request activity has been completed. Direction to go through the Edit Disclosure Profile SmartForm and go to the entity disclosure information section and the approved request section. Overall, a summary of how to submit copy and mark complete for the Pre-Approval Request.
